3. Terms of References for Internal Audit of Surat Sitilink Ltd.

The proposed scope of Internal Audit to be carried out for the **01.04.2026 to 31.03.2027** while the reporting will be based on 3-month periods June, September, December and March. It is a comprehensive scope covering verification of all the projects carried out by the Surat Sitilink Ltd- Special Purpose Vehicle (SPV) of Surat Municipal Corporation. It aims to give broad contours within which the audit would be carried out; however, it may evolve in the other areas based on the necessity, mandate and compulsion. The Scope is divided into following broad segments:

3.1 System & Procedural Audit

3.1.1 Accounts and Finance

- a) Fund Management including Drawing Segregation route between “A&OE”, “Funds received from Surat Municipal Corporation” and other funds out of Fixed deposits.
- b) Grant received from government.
- c) System and process for JV’s and controls related thereto.
- d) Compliance with various Accounting Standards.
- e) MIS - To ensure that the Information System is seamlessly integrated and has minimal manual intervention and there are adequate controls on financial and operational reporting.

3.1.2 Statutory compliances

- a) Verification of Investments & Investment Register.
- b) Contingent Liabilities
- c) Verification of Secretarial Compliances - To check all statutory records registers including Minute Books and to see that accounting effects of all the decisions taken at Board / Committee Meeting / General Meeting / Audit Committee in the Books of Accounts.
- d) Review on the Company’s dealing where related parties are interested.
- e) Fixed Assets Verification with Fixed Assets Register.

3.2 Pre-audit of transactions

3.2.1 Transaction & Compliance Audit

- a) Pre-audit of transactions before they are vouched for in the accounts.
- b) Contractual Arrangements verification with individuals and other entities.
- c) Stamp & Signature on each of the transactions as a token of pre-audit for processing the documents.
- d) Verification of Cash and Bank payments, FDR's, Security Deposits and receipt system.
- e) Review of all ledgers, Balance sheet and Profit & loss Account on quarterly basis.
- f) Visit as frequently as necessary so that no transaction remains unprocessed as a result of pre-audit for more than 24 working hrs.
- g) Opinion related to Direct Tax and Indirect Tax.
- h) Penalty maybe levied on the Internal Auditor for the delay, non-compliance, or any work related dissatisfaction at office of SSL. The amount of penalty will be determined by the management. Additionally, SSL reserves the right to deduct from the final fee payment at the discretion of management, if the work is not perform as per the work order.
- i) During the execution of the contract, if any change is made in the rate of GST (Goods and Services Tax) by the government, it will be refunded/collected separately by Surat Sitilink Ltd. For which the successful contractor will have to inform the competent authority along with the original receipt/proof of GST paid to the government within 30 days from the date of payment of the bill along with the certificate of their Chartered Accountant.

3.2.2 Payroll and HR Related Documents

- a) Verification of salaries and statutory deductions related documents e.g. Provident Fund, ESI, Professional Tax etc.

3.2.3 Budget:

- a) Base of the budget to be verified to ensure that sanctity of the budget is as per the Surat Sitalink Ltd.
- b) All the transactions entered into form part of the approved projects and are funded from allocations or grants received for the purpose

3.2.4 Other Areas / Responsibilities:

- a) Providing consultancy on various matters related to Compliances.
- b) Reporting to Audit Committee major observations and strengthening whistle blowing mechanism.
- c) Liaising with statutory auditors.
- d) Internal Auditor has to Compulsorily present 3 days in week and also as and when required by SSL remains present.
- e) Submit detail Quarterly Audit Report at the end of the Quarters.
- f) Regular reviews of the price escalations, Diesel hike rate differences certificate, Rate Revision certificate, Annual assured kilometers calculations certificate and related other certificate if any to be paid or recovered form the contractors as per the tender terms.

3.2.5 Security Deposit & Agreement

- a) The successful bidder will be required to place Security Deposit Rs.25,000/- of the consideration of the Contract by Demand Draft or Banker's Cheque Payable at Surat in favor of Surat Sitalink Ltd. of any scheduled/nationalized bank within 15 days from the date of notice of award of contact, failing which a penalty @ 0.065% of the amount of security deposit will be imposed for delay of each day.

- b) The Awardees i.e. the selected bidder will have to enter into an agreement with Surat Sitolink Ltd. on a stamp paper of appropriate value of Government of Gujarat at the bidder's own cost within 15 (Fifteen) days period from the date of Notice of Award.

3.2.6 Any other Areas suggested by the Audit Committee

- a) SSL reserve the right to cancel the engagement of internal auditor for captioned post without assigning any reason.

3.2.7 Contract Period

- a) Offer is invited for the period of **01.04.2026 to 31.03.2027**.
- b) Surat Sitolink Limited issue work order for one year on first instant and then extend for the two year after satisfactoral completion of one year.
- c) The yearly service charges shall be escalated upto 10% from previous work order (LOA).
