The contract for subjected work for FY 2025-26 is completed first three quarters and last quarter (4th) filing is completed by 31-May-26. Filing of income tax return for FY 2026-27 will start in April-26.

Many times, notices received from income tax department. On various provisions of income tax Act are to be replied & chased for their disposal by submitting suitable reply after doing necessary correction & uploading.

The reply & corrective steps are to be advised by a well known person of Income tax Act's provisions, so that pending demand notices & irregularities in filing can be resolved by filling correction's statement/ regular statement under different provisions of income tax Act.

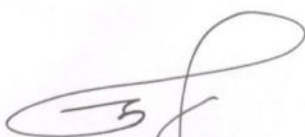
1. Scope of work for preparation / filling of quarterly E-TDS returns for all the TAN's of DRM office for upto FY 2026-27 is as under:

- Preparation /Compilation of all the related data for filling of TDS returns.
 - Cross checking of all the PAN No's including all the employees and contractors.
 - Providing the list of employees having in-correct PAN No. / No PAN Nos.
 - Monthly filling of Returns in Form 138.
 - Quarterly filling of Return in Form 140,141,142 and 143 along with 27A.
 - Revise filling of E-TDS returns in form 24G/138, Form 24Q/140, 26Q/141 and 27EQ/143 wherever necessary.
 - Providing copies of Form 16A for contractors on quarterly basis and monthly basis as applicable.
 - Preparation and submission of replies to all the notices raised by the income Tax Department.
 - Preparation and submission of summary reports of all the returns filed monthly, quarterly basis as required.
 - Providing consultancy on TDS matters and informing the management of the recent changes in the income tax laws on timely manner.
2. Filling of correction statement in respect of individual staff & contractor.
 3. Verification of PAN Numbers of staff and contractors to ensure correct filling of returns.
 4. Framing reply of income tax Department's Notices issued and submits the reply on behalf of all TAN's holder to income tax Department time to time.
